#### The Bachelor of Teaching (ECE)

- Applicants under 20 years of age must have gained a minimum of 60 credits at NCEA Level 2 across four subjects including a Language Rich subject (e.g. History, Classics, Media Studies or English) and a minimum of 14 credits at Level 1 in Mathematics, or equivalent
- or
- 42 credits at NCEA Level 3 including a Language Rich\* subject and a minimum of 14 credits at Level 3 in each of two subjects, and
- A further 14 credits at Level 3 from no more than two additional subjects, or equivalent

#### The New Zealand Certificate in Nanny Education

- Have completed a minimum of four years' secondary education with the final year being Year 12, and
- Achieved NCEA Level 1 with a minimum of 12 literacy credits,
- Show evidence of successful study at NCEA Level 2

Each application is individually assessed. Preference will be given to applicants who have gained the majority of their credits in subjects which demonstrate that they are likely to succeed in academic study at a tertiary level. As these results are not available when selection is taking place we would appreciate it if the school could provide some indication of the applicant's potential for meeting these requirements and undertaking a programme of tertiary study. Please note that we will still require applicants to submit verified copies of their results when these are available.
