#### 1. Admission and Entry

#### 1.1 General Academic Admission

Open Entry; however, it is preferred that applicants under 20 years of age have completed four years of secondary education, and at least 12 NCEA – unit standards credits (or equivalent at level 2). Suggested subjects include English, Physical Education and/or Biology.

## 1.2 Selection Criteria

For health and safety reasons applicants must declare any health conditions and hold a current comprehensive first aid certificate (Certificate (or acquire one within three months of commencing the programme).

#### 1.3 English Language Requirements

Candidates who have English as a second language are required to have an International English Language Test System (IELTS) score of 6.0 across all bands; or equivalent.

#### 2. Transfer of Credit

2.1 100% transfer of credit is available for this programme (both formal transfer of credit and recognition of prior learning).

### 3. Programme Requirements

- 3.1 Every candidate for the Certificate in Massage (Level 4) shall to the satisfaction of the Academic Board follow a programme of study for a period of normally not less than 21 weeks part-time (including 2 weeks holiday break).
- 3.2 Each candidate for the Certificate in Massage (Level 4) is required to complete the compulsory modules, totalling 45 credits.
- 3.3 Candidates must have a current Comprehensive First Aid Certificate prior to entering the programme or acquire one within three months of commencement of the programme.
- 3.4 Modules will be offered sequentially on a part-time basis to ensure that candidates have the opportunity to meet prerequisite conditions.
- 3.5 Progression through this programme is only offered on a part-time basis.

#### 4. Completion of the Programme



4.1 A candidate may take up to two years to complete this programme, unless an extension is granted by the Centre Director or designated equivalent, or authorised nominee.

#### 5. Award of the Qualification

5.1 Candidates who successfully complete the requirements of clause 3.1, 3.2 and 3.3 of these regulations will receive the award of the Certificate in Massage (Level 4).
